**Montgomery County Public Safety Building / Jail
PAVING SPECIFICATIONS**

1. SCOPE:

Paving two sections parking lot at the Montgomery County – Public Safety building and Jail of approximately 7,800 square feet.

2. SPECIAL CONDITIONS:

(A) Asphalt paving and patching shall be performed when temperatures are forty degrees (40) or higher for a minimum of 2 hours.

(B) Projects shall be completed within the 2016 annual year.

3. MEASUREMENTS:

All measurements indicated in the specifications are approximate and shall not be used to determine actual area. Vendors are responsible for preparing actual measurements and calculations.

4. DAMAGED ASPHALT:

The location has damaged areas that will require complete removal of material. The locations will be determined during the pre-bid site visit. Vendors are responsible for obtaining measurements and calculations for damaged area repairs.

(A) A minimum of six inches (6") of compacted 21A stone shall be placed as the base in the damaged area.

(B) Two inches (2") of compacted BM25 asphalt shall be placed over 21A stone base.

5. TRANSITIONS:

The location has transitions from the parking lot to:

(A) Streets.

Vendor shall saw-cut and mill existing asphalt a minimum of one and one half inches (1-1/2") deep and in adequate width to ensure a minimal depth of one and one half (1-1/2") inches of compacted asphalt is achieved.

6. TACK COAT:

A tack coat of CRS2 shall be applied to the entire area that is to receive overlay pavement.

7. OVERLAY ASPHALT:

Overlay asphalt shall be SM-9.5AL. Asphalt shall be one and one half inches (1-1/2") compacted.

8. Handicapped Ramp:

A handicapped ramp from the parking lot to the adjacent sidewalk shall be constructed with asphalt. The ramp shall be 52" wide and slope no greater than 1-12.

9. Restriping:

All parking spaces shall be re-stripped.

A copy of this warranty must be furnished with the bid.
