TITLE: Revenue Recovery for Emergency Medical Services

Amendments:

1. No further questions will be accepted after the issuance of this addendum.

Clarification:

1. Question: Do you currently outsource EMS Billing? If so, can you provide the name of the fee you are being charged?

Montgomery County Response: No, we do not currently bill for EMS.

2. Question: What is the reason for your RFP?

Montgomery County Response: Per the Purpose and Specific Background sections (pages 4 and 5) of the RFP, this is a new initiative. The County does not have the resources to perform this service in house so the RFP was issued.

3. Question: When is the anticipated contract start date?

Montgomery County Response: The County prefers to have this contract start July 1, 2023, but is open to discussion regarding this.

4. Question: When is the anticipated award date?

Montgomery County Response: The goal is to award sometime in June 2023, but this is subject to change.

5. Question: Are bidders permitted to deviate in any way from any manner of quoting fees you may be expecting? For example, if there is a pricing page in the RFP, can bidders submit an alternate fee structure? If there is no pricing page in the RFP, do you have any preference for how bidders should quote fees or can bidders create their own pricing categories?

Montgomery County Response: This RFP is for a new service. Per section X. PRICING SCHEDULE (page 12) of the RFP, Offerors should include a clear pricing schedule that explains costs, fees, shared revenue, etc. Offerors should propose solutions to the questions above.

6. Question: To what extent will the location of the bidder's proposed location or headquarters have a bearing on any award?

Montgomery County Response: The offeror's physical location is not likely to have a strong bearing on award as long as the company is properly licensed and capable to do business in our locality and in the Commonwealth of Virginia.

Montgomery County Response: Per the RFP statement of need, the County is currently using ESO and is currently not interested in utilizing a different ePCR platform. Offerors should be able to fully integrate with ESO.

Montgomery County Response: Both agencies (MCFEMS and BVRS) have mutual aid agreements with all adjacent jurisdictions and frequently provide aid to other agencies within Montgomery County
